Does this product provide normative inferences about student growth? If so, how?	<p>i-Ready Diagnostic is well-positioned to accurately measure student progress due to a number of factors. i-Ready Diagnostic is a psychometrically calibrated assessment. All items across all grades are placed on a common scale for each subject as part of the item calibration process. The item calibration process takes information collected from the item pilot and calculates item difficulty based on a common scale for each individual item. Students scores are also based on the same scale. This means that a measurement of student ability at one point in time is comparable to another measurement at a later point in time, whether that be later in the academic year, or the next academic year. Inferences about student growth can be made based on changes to their ability scale score over different periods of time.</p> <p>Furthermore, the adaptive nature of i-Ready Diagnostic means that students are not presented only with items relevant to their chronological grade level, but rather items with difficulties close to their ability estimates. Given the wide range of item difficulties available in the item bank, i-Ready Diagnostic is able to present students with items close to their ability to further refine measures for students with different abilities and grade levels.</p>

	<p>Information on normative growth is not yet available, as i-Ready Diagnostic is a newly created assessment. This type of data analysis will require a very large sample pool that can only come with extensive use of the assessment over a large and diverse geographic area. Curriculum Associates will be conducting further research over the coming 2011 and 2012 school year to collect this data.</p>

Assessment Overview

i-Ready Diagnostic Reading and Math Assessment is an effective, research-based combination of an adaptive diagnostic assessment and instant detailed reporting tool. i-Ready provides a powerful reporting suite for immediate results of essential performance information about every school, grade, class, and student. Diagnostic results are translated into easy-to-understand reports and are immediately available to teachers and administrators by grade level and domain. Reporting allows teachers to identify the instructional needs of students. A grade-level placement score by domain is defined for each student.

The adaptive nature of the assessments meets students at their own skill level, so they always experience success. i-Ready Diagnostic Assessment adapts to the students' responses avoiding frustration for the student by building on the "known" to accurately measure skill mastery.

Each student takes an online diagnostic that assesses students down to the sub-skill level in reading and math. Computer adaptive algorithms ensure students are assessed efficiently across a number of domains of knowledge. The questioning format adapts as students respond to each question, getting easier or harder, as needed, to complete the diagnosis and identify each student's performance level. As a pretest and posttest to instruction, the assessment is detailed, precise and delivers immediate reports.

Alignments to the domains and strands of the Common Core State Standards and the current NY State Learning Standards for ELA (Reading) and Math are available. Math and Reading Instruction modules are available as an Add-On to the Diagnostic. The Instruction adapts to the students performance level to deliver differentiated instruction.
