ReadiStep™ is a standardized national assessment for 8th graders that measures ELA and mathematics skills. The College Board is a not-for-profit membership organization whose mission is to connect students to college success and opportunity. The College Board works with over 5,700 schools, colleges, universities, and other educational organizations, serves more than seven million students and parents and 3,800 colleges and universities in over 180 countries and territories, as well as policymakers on the national and state levels. The College Board also maintains relationships with more than 900 key school districts across the country. College Board services pertinent to this RFQ include assessments such as AP®, ReadiStep™, PSAT/NMSQT®, ACCUPLACER®, SAT®, and SAT Subject tests. In addition to its main offices, the College Board maintains six regional offices to better serve schools and districts nationwide. The Middle States Regional Office serves the state of New York. Staff at the national and regional levels will provide the services necessary to provide ReadiStep to districts state wide. The College Board has provided ReadiStep nationally for one school year and in Texas for two school years and delivers results in a timely manner (approximately 4 weeks from the test administration). The College Board provided ReadiStep assessments to approximately 250,000 students nationwide in the 2010-11 school year. The College Board has the capacity to provide ReadiStep to all 8th grade students in the State of New York. Technical assistance regarding test administration is available at no cost. Optional technical assistance, in the form of teacher workshops, is available at a cost to be negotiated with the district.
